- Registered with Suruhanjaya Syarikat Malaysia (“SSM”)
- Have less than 5 years of business operations

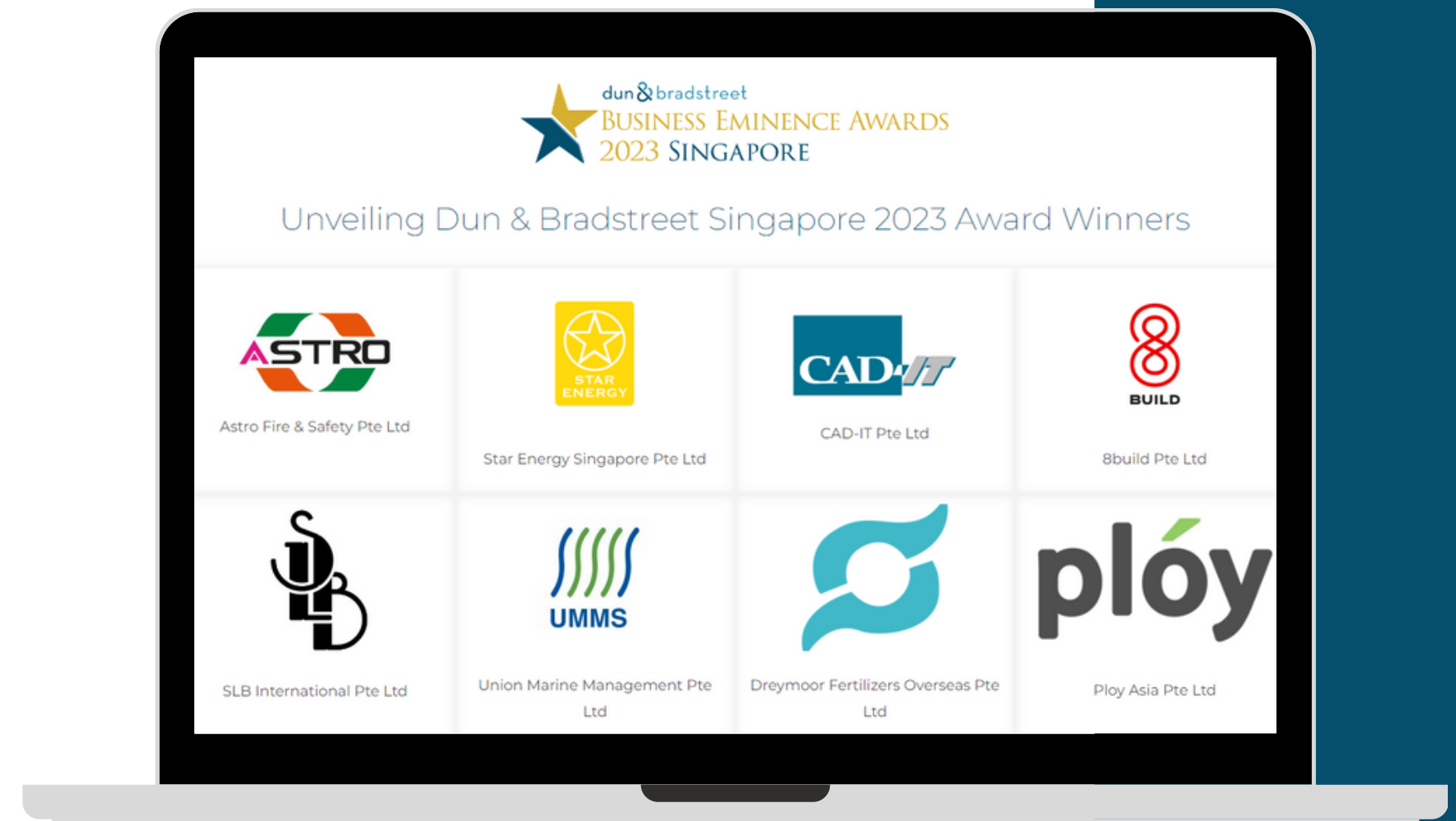
